



## First Responder Network Authority (FirstNet) Weekly Update to the State Single Points of Contact (SPOCs) – March 9, 2015

### FirstNet News

- Today the FirstNet Board approved for release a second Public Notice (Second Notice) for comment. The primary purpose of this Second Notice is to seek public comment on key interpretations of the Act that impact operational and economic issues regarding the planning, deployment, operation, and sustainability of the NPSBN. Once the Second Notice is posted in the Federal Register, written comments may be submitted electronically within 30 days to [www.regulations.gov](http://www.regulations.gov) or by mail to the address listed in the notice. We have posted an [FAQ about the Second Notice](#) on our website.
- Last week, FirstNet participated in a California Town Hall, the Industry Council for Emergency Response Technologies (iCERT) and First Responder Network Security Summit, the Pennsylvania Southcentral Regional meeting, the National Fire Protection Association Board meeting and the Fraternal Order of Police Board meeting.
- This week, FirstNet will be participating in the Massachusetts initial consultation meeting, the National League of Cities (NLC) Congressional Cities Conference, the APCO Emerging Technology Forum, the Armed Forces Communications and Electronics Association (AFCEA) Homeland Security, and the National Fire Protection Association (NFPA) 1802 Committee meeting.
- FirstNet is looking forward to the annual IWCE conference and exhibit next week in Las Vegas. Senior staff and Board members will be participating on a number of panel sessions, including: legal and regulatory issues, cybersecurity, early builders, FirstNet integration, NG9-1-1 and public/private partnerships.
- FirstNet, in coordination with the NTIA State and Local Implementation Grant Program (SLIGP) Team, will host the 2015 SPOC Meeting on April 14-15, 2015 in Reston, VA. This two day meeting will be designed to discuss the FirstNet and SLIGP updates, solicit state and territory feedback on FirstNet planning activities, and provide a forum to share successes and lessons learned on FirstNet planning efforts. The meeting will be held at the Hyatt Regency Reston located at 1800 Presidents Street, Reston, VA. A block of hotel rooms has been reserved at the Hyatt. The 3/4 consultation meeting with the state of Arkansas was cancelled by Arkansas due to inclement weather and will be rescheduled for April. We have held 15 consultation meetings thus far with more than 1,100 total stakeholders.

- To date, FirstNet has received completed consultation checklists from 48 of 56 states and territories: Alabama, Arkansas, California, Colorado, Delaware, Florida, Georgia, Guam, Hawaii, New Hampshire, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Maryland, Massachusetts, Michigan, Minnesota, Missouri, Montana, Nebraska, Nevada, New Jersey, New Mexico, New York, North Carolina, North Dakota, Ohio, Oregon, Pennsylvania, Puerto Rico, Rhode Island, South Carolina, South Dakota, Tennessee, Texas, Virgin Islands, Utah, Vermont, Washington, Washington DC, West Virginia, Wisconsin, Wyoming.

- The next FirstNet Board and Committee meetings will be March 24-25 at the Department of Commerce headquarters building in Washington, DC. More information regarding registration and the agenda will be forthcoming.

## From the States and PSAC Organizations

- The Pennsylvania (PA)-FirstNet team held its third of nine regional meetings on March 6 in Shippensburg, PA to continue education on FirstNet and begin promoting data gathering. Agenda items included a FirstNet and PA-FirstNet overview and update, an LTE overview, a presentation by Texas on the benefits of public safety broadband communications, and an overview of the planned data gathering activities/surveys. The PA-FirstNet team plans to hold the remaining regional meetings through May and will highlight the findings from the requirements gathering activities at a statewide conference. - In response to a request from the PSAC, the Tribal Working Group (TWG) met via teleconference last week to finalize recommendations regarding FirstNet tribal outreach, education, and inclusive consultation strategies. The group also expressed interest in continuing to offer advice and assistance.
- The PSAC priority and preemption task team had a call on 3/4 to discuss the draft usage scenarios. Staff also held a call with the PSAC EC on user equipment on 3/4.
- Dates were set for the in person priority and preemption and public safety grade task team meetings in Boulder, CO for 4/7-8.

Wireless broadband data applications enable exciting new possibilities for improving the operations and effectiveness of California public safety activities in life changing – and lifesaving – ways. The First Responder Network Authority (FirstNet) plans to issue another public notice further exploring issues related the definition of public safety entity, a FirstNet official said today at the National Emergency Number Association's 911 Goes to Washington event. The definition of public safety entity was an issue that drew many comments in a public notice issued by FirstNet last September (TRDaily, Sept. 17, 2014). The public notice sought comment on preliminary interpretations and other issues regarding FirstNet's authority under the Middle Class Tax Relief and Job Creation Act of 2012. Vicki Lee, FirstNet's association manager, said at today's event that FirstNet plans to issue a public notice that will solely further explore issues and interpretations related to the definition of public safety entity. She said she did not know when the public notice would be released.
