



## First Responder Network Authority Weekly Update to the State and Territory Single Points of Contact (SPOC) – July 18, 2016

### FirstNet News

- Mike Bostic joined the FirstNet team last week as the Senior Law Enforcement Advisor. Mike served with the Los Angeles Police Department for 34 years, retiring as an Assistant Chief. Most recently, he served as the public safety advocacy director in Raytheon Company and Nokia Corporation, focused on public safety communications. Mike has a wide spectrum of policing experience and held significant roles in communications and information systems in both policing and the private sector. - FirstNet has now completed 30 State Governance Body Consultation Meetings. Last week included meetings in Oklahoma with the Public Safety Broadband Governing Board and in West Virginia with the Statewide Interoperable Executive Committee. Primary discussion topics at both included the 90-day State Plan review and decision process, the importance of tribal input to the opt-in/opt-out decision, and rural coverage.
- Last week, FirstNet Board Member Governor Jim Douglas and Director of Government Affairs Edward Parkinson traveled to Des Moines, Iowa for the annual summer meeting of the National Governors Association (NGA). There were no formal FirstNet presentations, but both engaged in informal discussions with various governors and governors' staff.
- Also last week, FirstNet hosted a Region 5 Quality of Service, Priority, and Preemption (QPP) Consultation Task Team (CTT) meeting in St. Paul, Minnesota, with 37 attendees. Attendees provided valuable feedback regarding the need for standardized policies and procedures, including the importance of documenting requirements for local network control.
- The Federal Consultation team is preparing for a FirstNet Federal Southwest Border Forum in Phoenix, Arizona on August 30-31. This meeting will provide an opportunity for federal stakeholders in and around the Southwest Border Region to engage with FirstNet through a series of presentations and breakout session(s) focused on what is possible with public safety LTE and understanding federal needs. Through this meeting, we will keep federal stakeholders informed and up-to-date on FirstNet developments and current efforts, expand outreach to regional stakeholders, and gain a better understanding of how to support federal operational needs in the region. RCR Wireless News 7/13: Rivada Networks looks to tap new technology to bolster FirstNet

The First Responder Network Authority was provided with the 700 MHz D-Block license and more than \$6 billion in funding from the FCC's AWS-3 spectrum auction to entice firms into a new partnership. This effort has drawn interest from a number of established carriers, including Verizon Wireless and AT&T, as well as new entities. One of those entities is Rivada Networks. Rivada last month unveiled vendor partners lined up to help the company in its efforts to build out a nationwide public safety network should it win a part or all of the FirstNet bidding process. Rivada said partners include Harris Corporation, Ericsson, Nokia, Intel Security, Fujitsu Network Communications and Black & Veatch.
