# PSAC December 2019 Meeting highlights past year's progress and previews FirstNet in 2020.

On December 10<sup>th</sup>, the First Responder Network Authority (FirstNet Authority) hosted its bi-annual Public Safety Advisory Committee (PSAC) meeting in Austin, Texas. The meeting brought together more than 20 PSAC members with FirstNet Authority leadership, senior staff, and Board members, as well as representatives from AT&T and the National Institute of Standards and Technology (NIST), to discuss FirstNet's 2019 accomplishments, plans for network expansion in 2020, and initiatives to grow FirstNet's public safety ecosystem.

PSAC Chair **Todd Early** welcomed PSAC members with remarks that underscored the significance of the PSAC mission to ensure that first responders gain nationwide access to FirstNet. FirstNet Authority's **Ed Parkinson's** opening remarks highlighted PSAC's input on the FirstNet Roadmap and its six technology domains. These efforts were pivotal in developing a strategic plan to advance the network's future investments.

PSAC Chairman Todd Early lead discussions that included an overview of the Tribal Working Group's 2019 activities and accomplishments, PSAC's webinar series, and the newly implemented Strike Teams. Todd took the opportunity to welcome new PSAC members **Chief Greg Rubin** of the International Association of Fire Chiefs and **Reenie Askew** of the U.S. Conference of Mayors, both in attendance for their first PSAC meetings.

Todd welcomed **Jason Porter** as the new head of the AT&T FirstNet team and thanked him for his dedication to the

FirstNet mission. Jason highlighted **FirstNet adoption in 2019**, and continued plans for network deployment and expanded coverage in 2020.

The PSAC also heard a detailed briefing from **John Beltz**, IT Security Manager for the Communication Technology Laboratory from NIST. John discussed the important work the team is doing around SIM card challenges and Identity, Credential, and Access Management (ICAM) solutions.

During the afternoon sessions, the FirstNet Authority's Roadmap was central to the discussion. Focusing on Voice Communications and Situational Awareness, PSAC members took the opportunity to relay their personal experiences on the network, both day-to-day and during emergency response. The FirstNet Authority team discussed how the Roadmap will continue to guide the development and evolution of the network, and previewed the 2020 engagement strategy and approach with public safety stakeholders.

The day concluded with a demonstration by the Brazos County (TX) Sheriff's office showcasing their use of FirstNet. As the first Texas agency to officially subscribe to FirstNet, the network has improved situational awareness throughout the rural county.

Overall, the meeting showcased the PSAC's successful work in 2019, and brought productive and enthusiastic discussion about future work. Thank you to all participants and attendees. On behalf of the FirstNet Authority, we wish you and your families a very happy and healthy new year.
