FirstNet Authority holds first of two informational webinars about Roadmap Update

The FirstNet Authority held the first of two webinars on the recently revised **FirstNet Authority Roadmap**. FirstNet Authority leadership and staff outlined the data-driven approach used to update the Roadmap and its priorities. The online forum gathered over 250 public safety stakeholders representing law enforcement, fire services, EMS, emergency management, and 911 services – many of whom played a vital role in providing valuable input to keep the Roadmap current and specific to their operational needs.

Executive Leadership Welcome. Chief Executive Officer **Ed Parkinson** and Acting Chief Market Engagement Officer **David Buchanan** from the FirstNet Authority welcomed the audience, thanking them for recent and continuing contributions to the Roadmap. Ed emphasized that the FirstNet Authority relies on Roadmap input from responders to guide our efforts to enhance FirstNet and to deliver a differentiated experience for first responders.

FirstNet Authority Board Chair **Robert "Tip" Osterthaler** followed with remarks emphasizing that public safety's Roadmap feedback will influence FirstNet Authority activities, programs, and investments. Tip remarked that the FirstNet Authority relies on this feedback to keep FirstNet current and align the network with public safety's needs.

"We are only as good as the input that public safety gives us. Please continue to provide us with your inputs – we can't have a Roadmap without you." – Chairman Osterthaler

The Roadmap Update Explained. The FirstNet Authority team facilitated the hour-long program around three main elements to explain the 2020 Roadmap Update: an overview of the Roadmap's content and structure, research methodology, and what the FirstNet Authority has in store for the Roadmap's future.

Senior director of the Roadmap Development Division, **Brian Hobson** provided an overview of the four main sections found in the 2020 Roadmap Update. He detailed the Roadmap's structure, including the first two investments and findings, overviews for the six domains, and a new research addendum.

Executive Advisor, **Chuck Shaughnessy** led a discussion outlining the FirstNet Authority's four-pillar research effort to update the Roadmap. The team relied on data collection from public safety, executive-level interviews, in-depth

publication review, and polling. Chuck explained how this provided the Roadmap with insights to help identify and pursue technology innovation, policies, and programs that benefit public safety.

Director for Network Solutions, **Dr. Jennifer Harder** and Senior Manager for Stakeholder Collaboration, **Michael Varney** discussed future plans for Roadmap engagements. In addition to general data collection, in the coming year, the FirstNet Authority team will employ more focused data collection methods, such as surveys, one-on-one discussions, and focus groups, to gain a broader perspective from the responder community. These methods will be used to address topics and issues that are critical to public safety, such as in-building coverage challenges, location-based services features, and specific elements related to Identity, Credential, and Access Management.
