## FirstNet Faced Extraordinary Challenges; Passed the Ultimate Stress Test

In the past year, first responders relied on FirstNet for innovative solutions and capabilities to meet the real-world demands of wildfires, hurricanes, and a global pandemic. Last week's AT&T Policy Forum examined how the FirstNet network faced these challenges.

FirstNet Authority **CEO Ed Parkinson** led a fireside chat with **Congressman Bob Latta**, ranking member of the Communications and Technology Subcommittee of the U.S.
House of Representatives Committee on Energy and Commerce, and one of the principal architects of the legislation that created FirstNet. Congressman Latta explained that, as envisioned by Congress, the successful implementation of FirstNet required the nationwide network to be built out in rural and urban areas and widely used by public safety.

Parkinson and Latta discussed how the AT&T-FirstNet Authority public-private partnership helped shape the network to meet these expectations – with **more than 16,000 public safety agencies** using FirstNet's expanded coverage and increased capacity to support disasters, critical incidents, and planned events.

Public Sector FirstNet-AT&T President, **Jason Porter**, moderated a discussion with four public safety professionals on how they harnessed FirstNet to support their day- to-day operations, COVID-19 response, and other emergencies.

#### City of Vail, Colorado Police Department

Chief Dwight Henninger first became familiar with FirstNet in 2015 when participating in a **FirstNet demonstration at the World Alpine Ski Championships**. During the two-week event, thousands of people descended on the City of Vail causing network congestion for responders on duty. With FirstNet on site, the network provided Band 14 data transmission capability to local police officers, deputies, paramedics, and firefighters. "At the end [of the demo] we couldn't get the [devices] back from them, they liked them so much," recalled Chief Henninger. "Everybody was very happy that it worked in such difficult weather and terrain situations."

### Navajo Nation Telecommunications Regulatory Commission (NNTRC), Arizona

At the peak of the pandemic, NNTRC Executive Director **Christopher Becenti** requested a FirstNet deployable asset to support emergency communications for the Navajo Nation's first responders and Federal Emergency Management Agency (FEMA) personnel. Tribal first responders also used deployables during the Navajo Nations Fair in Window Rock, Arizona and when First Lady Jill Biden visited the Navajo Nation in April 2021.

Becenti said that the FirstNet Authority's Public Safety Advisory Committee (PSAC) **Tribal Working Group** (TWG) is a "direct line of communication" with the FirstNet Authority. "The input from the TWG helps make sure tribal first responders remain at the forefront and informed the future buildout of FirstNet," noted Becenti. "It definitely gives abilities to tribal nations to voice their concerns, especially for their locations that the initial buildout may not cover."

#### Redmond Fire Department (RFD), Washington

When Fire **Chief** (Ret.) **Tommy Smith** arrived at Redmond Fire Department in 2013, he learned the department used aid agreements with nearby public safety agencies to share resources and lend support. Knowing that interoperable communication is essential across disciplines and jurisdictions, Smith sought out FirstNet for RFD and other interested police, fire, EMS, and public works agencies. "The transition for Redmond was pretty seamless," recalled Chief Smith. "We actually saved money by going to FirstNet and improved services to communicate with the individual responders and agencies in our area." As a FirstNet user, RFD has relied on FirstNet's priority and preemption and always-on connection while battling wildland fires across Western Washington.

### Department of Emergency and Customer Communications (DECC), City of Alexandria, Virginia

The Emergency Communications Center in Alexandria, Virginia used FirstNet to seamlessly continue operations while working remotely during the COVID-19 pandemic. At the height of the pandemic, DECC Director **Renee M. Gordon's** team used **FirstNet's mobile hotspots** to connect with call queues and computer added-dispatch capabilities. With FirstNet's remote solutions, telecommunicators were able to handle high call volumes while working remotely and staying safe. "To maintain the safety of our staff and promote continuity of ops during the pandemic, we developed a solution that allowed 911 call answering to happen remotely," explained Gordon. "FirstNet's reliability gave us the confidence that we could support [this capability]."
