# FirstNet Authority Board approves FY 2022 Budget; FirstNet Authority CEO highlights FY 2021 accomplishments and lists FY 2022 priorities

On August 18, the FirstNet Authority Board held its latest quarterly meeting. During the meeting, **the Board approved the FirstNet Authority's budget for fiscal year 2022 (FY22)**, including \$79.3 million for FirstNet Authority operations, \$94.1 million in investments into the nationwide public safety broadband network, and \$79.3 million in reserve funds.

FirstNet Authority CEO **Ed Parkinson** highlighted the FirstNet Authority's top accomplishments in FY21 and looked ahead to the priorities for FY22.

#### Top Accomplishments in FY21 included:

*Evolving the network* 

- Delivered access to AT&T 5G and expanded the fleet of deployables by 15
- Launched and evolved mission-ready tools, such as Z-axis, high-power user equipment, compact rapid deployables, and FirstNet push-to-talk
- Expanded Band 14 to rural areas, tribal communities, and where public safety said they needed coverage most

Working with public safety

• Helped public safety integrate FirstNet into operations

- Completed an after-action review of the Christmas Day bombing in Nashville, in collaboration with public safety stakeholders
- · Led a working group on wildfire response

#### *Driving the future*

- · Conducted rigorous oversight of the FirstNet contract
- Released an updated FirstNet Authority Roadmap
- Held 1,200+ engagements across all states and territories, levels of government, and disciplines

#### **Key Priorities for FY 2022:**

Contract oversight: Maintain vigorous contract oversight to ensure that AT&T delivers on the nationwide public safety broadband network, while preparing for transition from initial build-out to future enhancements

Stakeholder engagement: Collaborate with public safety, industry, and government entities to demonstrate and obtain feedback on the operational benefits of wireless broadband for public safety operations and to inform future investments

Future planning and investment: Plan and invest in future capabilities, services, and policies to evolve the FirstNet network in alignment with the FirstNet Authority Roadmap

Organizational health: Evolve and streamline the FirstNet Authority's processes and procedures to best use the organization's capabilities and resources

#### Thanks to outgoing members

Chair **Tip Osterthaler** thanked Board members **Neil Cox** and **Edward Horowitz** and **Public Safety Advisory Committee** (PSAC) Chair **Todd Early** for their service to FirstNet and the FirstNet Authority. Neil and Ed have completed their terms with the Board.

After six years serving on the PSAC, including three years as chair, Early announced his retirement from the Texas Department of Public Safety and thus the PSAC. Under Todd's leadership, the PSAC has benefitted from his expertise, experience, and valuable input throughout his tenure.

"I want to thank the Authority, Board, and PSAC for allowing me to be a part of FirstNet and the work that's been done to build and enhance a network that equips first responders to save lives and protect communities. It's been a great honor," said Early.

The FirstNet Authority reiterates its profound appreciation for Todd's leadership and contribution to the network. His successor will be announced by the FirstNet Authority in the near future.

#### 3GPP Declares Release 17 Stage 2 Architecture Standards Frozen

The second quarterly Third Generational Partnership Project (3GPP) Plenary e-meetings of 2021 focused on the completion of Release 17 (R17) stage 2 (architecture) work and preparation for prioritization of features for R18. The group declared the stage 2 work frozen, while allowing some work items to continue into the third quarter of 2021. At this time, the R17 stage 3 (protocol) freeze date remains on schedule for March 2022.

#### AT&T Unveils New Disaster Response Technology for RIEMA

Governor Dan McKee, Director Marc Pappas of the Rhode Island Emergency Management Agency (RIEMA), Deputy CEO Lisa Casias of the FirstNet Authority, and AT&T unveiled new FirstNet equipment and technology for Rhode Island first responders. As part of the state's plan when opting into FirstNet, AT&T has delivered two new Compact Rapid Deployables (CRDs) to RIEMA. Rhode Island is the first state in the country to receive CRDs as a part of the state's decision to advance its public safety broadband communications with FirstNet.
